<b>Minimum Qualifications</b>	Candidates with a Ph.D. degree or those who have submitted their thesis for the Ph.D. degree are also eligible to apply. The thesis must be in the relevant discipline.

<b>Tenure</b>	The initial offer will be for one year and renewable up to 2 years.
<b>Age</b>	Not more than 35 years as of the closing date of the advertisement.
<b>General Information / Details about the Position</b>	<ol style="list-style-type: none"> <li>1. The appointment is purely temporary and will terminate automatically without any notice.</li> <li>2. Appointment of the applicant will be governed by the terms and conditions of the institute.</li> <li>3. Accommodation will be provided in the institute campus as per institute norms.</li> <li>4. All qualifications should be from UGC-recognized universities / Deemed Universities / AICTE-approved institutions / Institutions of National Importance.</li> <li>5. Reservation as per Govt. of India norms will be followed.</li> <li>6. It would <b>not</b> be obligatory on the part of the Institute to call every candidate for an interview who may possess the essential qualification.</li> <li>7. The institute reserves the right to shortlist the candidate based on merit. No representation in this regard will be entertained by the Institute from any candidate.</li> <li>8. No TA/DA will be admissible for appearing for the interview.</li> <li>9. No interim enquiries/correspondence / communication of any sort will be entertained on the matter.</li> <li>10. The application should include the candidate's updated Curriculum Vitae (CV) highlighting their academic and research achievements (two recent publications).</li> <li>3. Additionally, candidates are required to attach a detailed (minimum 500 words) research proposal in the application, outlining the objectives of the research work they intend to undertake during the fellowship period. <i>Note: Sending only a resume / CV by email will not be considered as a complete application.</i></li> <li>4. The shortlisted candidates will be notified by email for interview. Therefore, please mention active Mobile Number and Email ID in the resume / CV.</li> <li>5. Recent passport size photographs and photocopies of relevant certificates and other testimonials in support of age, qualification, experience etc. will be collected at an appropriate stage.</li> <li>6. The applicant will be responsible for the authenticity of information submitted / documents and photographs. It is the responsibility of the candidate to assess his / her own eligibility for the post(s) for which he/she is appearing in accordance with this advertisement. If it is detected at any time in future, during the process of selection or even after the appointment that the candidate was not eligible as per the prescribed eligibility criteria in this advertisement, which could not be detected at the time of selection for whatsoever reason, his/her candidature / appointment shall be liable to be cancelled / terminated immediately.</li> </ol>
<p><b>Selection Process</b></p>	<ol style="list-style-type: none"> <li>1. An Expert Committee, appointed by the Director, will scrutinise all applications.</li> <li>2. The Comprehensive application reviews occur quarterly, specifically around the dates of April 30th, July 31st, October 31st, and January 31st in each calendar year. Following these review dates, candidates can expect to receive a decision within 30 days subject to availability of positions.</li> </ol>
